# **Advantages of being legally compliant**

There are many benefits of being legally compliant, including all of the following:



Be safeguarded for any legal requirement- for example, vigilance raids on storage, any legal case by a competitor, non-payment by a buyer etc.



Lead to development of strong institutional systems for FPOs – like bookkeeping, governance, monitoring etc.



Raising of finance for FPOs – by fulfilling requirements like financial statements, legal documents, collateral etc.



Can enter into Agreements and do transactions – like with a buyer for marketing of produce.



**Contributes to transparency and accountability.** 





# Legal compliances for a Producer Company

4	Annual General Meeting (AGM)	Once in a year before six months after the close of the financial year	September

6	Annual returns with RoC	Within 30 days of AGM	October
7	General reserve	Once in a year	Once in a year
8	Auditor appointment	By the AGM	September
9	GST returns filing	12 (Once in a month)	Every month
10	Extraordinary General Meeting (EGM)	As and when required	Any time as per requirement

# **Board Meeting of FPO**


Minimum one Board Meeting should be done once in a quarter or 4 BoD meeting in a year but the best practice is that the Board members of FPO meet once in a month on a fixed date and discuss on key matters and review the activities of the FPO from time to time.





# **Statutory audit of FPO**

A statutory audit is an independent assessment of the financial accounts of a company or institution. Statutory audits must be completed by qualified Chartered Accountants (CA) who are independent of the Business selected through AGM. It should be done by every financial year (April).






# **Annual General Meeting (AGM) of FPO**

Annual General Body Meetings must be conduct at least once in a year before six months of the closure of the financial year and It is the responsibility of Board to conduct Annual General Body Meetings during the month of September.








# **Election of Board members of FPO**


One third of the Board members have to retire and elections have to be held for these positions every year. The best practices it should be conducted before AGM during the month of August.





# **Annual Returns with RoC for FPO**

The Annual Returns must be done within 30 days of AGM and BoD are accountable to fill up annual return on time.






